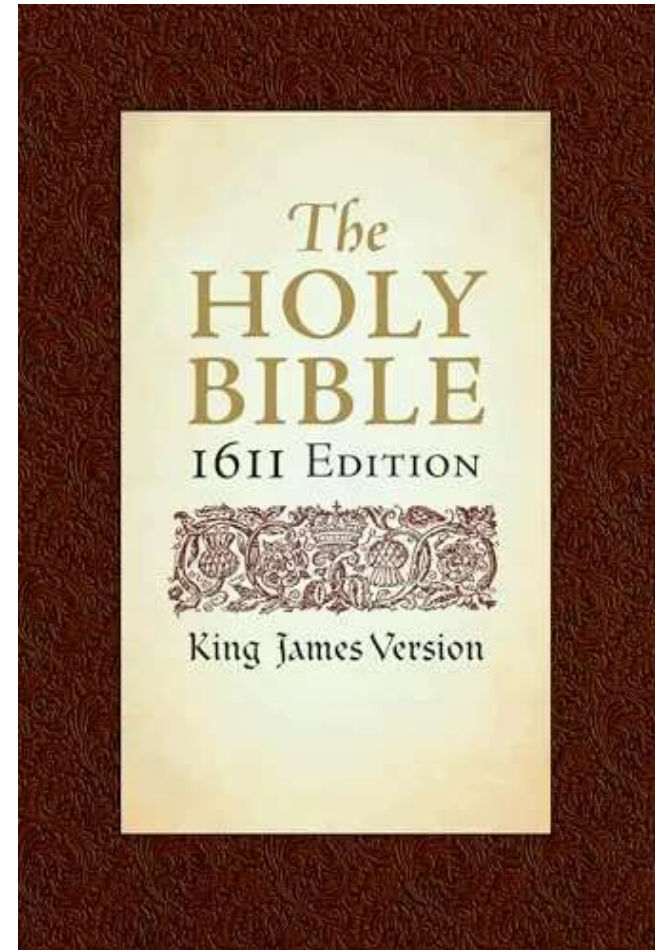

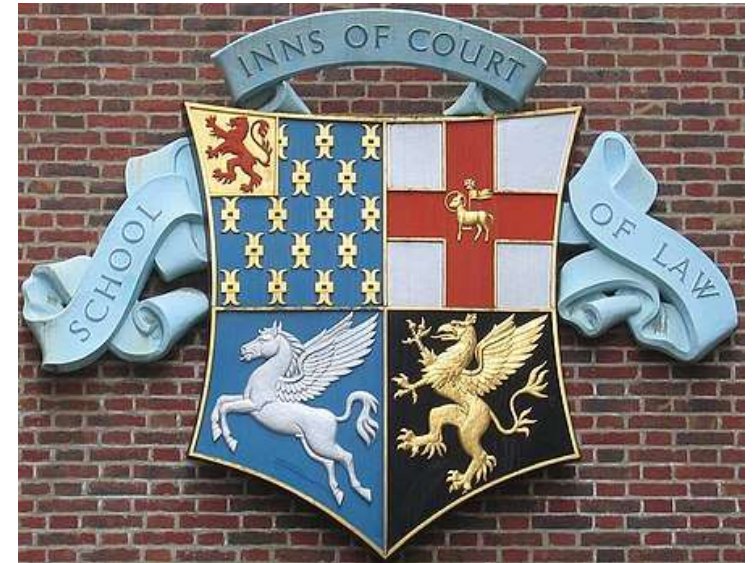

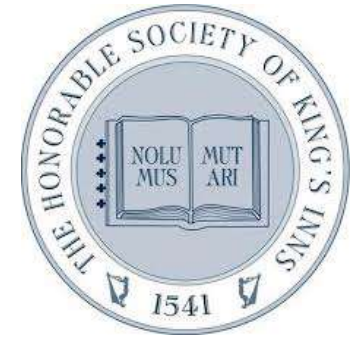

Ireland – The Law Societies

- The Law Society of Ireland – 1830
 - Incorporated by royal charter from Queen Victoria on 5 April 1852 under the name of "**the Incorporated Society of Attorneys and Solicitors of Ireland**". The charter referred to founding "*an institution for facilitating the acquisition of legal knowledge*", and for the better and more convenient discharging of professional duties of attorneys and solicitors.
- The Incorporated Law Society of Northern Ireland - 1922
 - commonly known as The Law Society of Northern Ireland, is a professional body established by Royal Charter granted on 10 July 1922 and whose powers and duties are to regulate the solicitors' profession in Northern Ireland with the aim of protecting the public.

“You do swear by Almighty God to be a true and faithful Servant unto The King’s Majesty as one of His Majesty’s Privy Council. You will not know or understand of any manner of thing to be attempted, done or spoken **against His Majesty’s Person, Honour, Crown or Dignity Royal**, but you will lett and withstand the same to the uttermost of your power, and either cause it to be revealed to His Majesty Himself, or to such of His Privy Council as shall advertise His Majesty of the same. You will in all things to be moved, treated and debated in Council, faithfully and truly declare your Mind and Opinion, according to your Heart and Conscience; **and will keep secret all matters committed and revealed unto you, or that shall be treated of secretly in Council**. And if any of the said Treaties or Counsels shall touch any of the Counsellors **you will not reveal it unto them but will keep the same until such time as, by the consent of His Majesty or of the Council, Publication shall be made thereof**. You will to your uttermost bear Faith and Allegiance unto the King’s Majesty; and **will assist and defend all Jurisdictions, Pre-eminences, and Authorities, granted to His Majesty and annexed to the Crown by Acts of Parliament, or otherwise, against all Foreign Princes, Persons, Prelates, States, or Potentates** . And generally in all things you will do as a faithful and true Servant ought to do to His Majesty.

I am a Constable with the Police Service of Northern Ireland; and I am currently attached to Strand Road Police Station in Londonderry. On Sunday 1st November 2020 I was on duty within Londonderry in full uniform when at approximately 21:50 hours I attended Londonderry the home a female I know to be a Dr Anne McCloskey DOB 01/06/1957 of Londonderry. Dr McCloskey answered the door and was informed by myself that she would be receiving a Covid Penalty Notice for the offence of Contravention of a requirement without reasonable excuse under regulation 8. This was due to an anti-mask protest she had attended, being one of the key speakers on Sunday 1st November 2020. When asked if she would be willing to accept the ticket she stated 'no I would rather go to Maghaberry first'. Dr McCloskey was therefore cautioned at 21:54 hours for Breaching Covid Regulations and cautioned using Article 3 of the Criminal Evidence (NI) Order 1988 'You do not have to say anything but I must caution you that if you do not mention when questioned something which you later rely on in court it may harm your defence, if you do say anything it may be given in evidence.' Dr McCloskey made no reply to caution. She was then informed she would be reported to the Public Prosecution Service for the offence. [Redacted]
