

Why Does the **DEPARTMENT OF HEALTH (NI)**'s Consultation Document dishonestly mislead, and try to deceive the people?

The **Department of Health's** Public Health Bill (Northern Ireland) consultation document claims 'in the main to mirror':

- (1) the Public Health (Control of Disease) Act 1984 [England and Wales] (paragraph 196)
- (2) incorporate some aspects of the Public Health etc. (Scotland) Act 2008 (paragraph 196) and
- (3) update the Public Health Act (Northern Ireland) 1967 [Parliament of Northern Ireland]

Only it does NOT, as the **Department of Health's** consultation document changes Parliament's definition of '**medical treatment**' to **not include vaccination and other prophylactic treatment.**

What's next - to be admitted to hospital in NI will you be required to be vaccinated and agree to take Remdesivir?

Why would these rouses try and change the definition of 'medical treatment**'?**

45E Medical treatment

(1) Regulations under section 45B or 45C may not include provision requiring a person to undergo medical treatment.

(2) "**Medical treatment**" **includes vaccination and other prophylactic treatment.**

86F Exclusion of requirement to undergo medical treatment

(1) Regulations under section 86A(1) may not include provision requiring a person to undergo medical treatment.

(2) "**Medical treatment**" **includes vaccination and other prophylactic treatment.**

94 International travel

(1) The Scottish Ministers may by regulations make provision for the purposes of or in connection with—

...
(2A) Regulations under subsection (1) may not include provision requiring persons to undergo medical treatment.

(2B) In subsection (2A), "**medical treatment**" **includes vaccination and other prophylactic treatment.**
