

ENVELOPES AND PAPER SIZE GUIDE



What you will need (the importance of being organised cannot be stressed enough): You will need a printer for your Affidavit of Status and of truth

1.1 What type of paper?

Available in White, Blue or Cream: For documents you will need Basildon Bond A4, 100gram watermarked writing pad (can be used for printers) with 1 sheet of bold lined paper – it helps you to keep your handwriting tidy and you will use this in the future for handwritten documents. - 1.3 Two x 3 sheets of A4 pastel blue 120g card for the front and back of your Affidavit of truth (this is optional, but it looks good).
- Go to the post office and obtain either a roll of special delivery/or 'Signed for' labels.

 These are *free. *You only pay when you use the postal service to ship your document.
- 1.5 Eyelet Rivet kit to (bind your master) document which has a 6mm Single hole punch/ or a Rapesco Superclip tool with clips never use staples, as this damages your document these can be purchased from WHSmith, Ebay or Amazon/ or any **local stationers**.
- 1.6 Pack of 10 x C4 brown envelopes you will probably need more.
- 1.7 1 x red postal ink pad so that you can thumb print notices found on Ebay https://cutt.ly/oDhhVSc
- 1.8 1 x blue postal ink pad so that you can thumb print bills of exchange/promissory notes after you have corrected your status.
- 1.9 1 x pack of blue ink biro's
- 1.10 A sheet of 25 x £1.00 postage self-adhesive stamps (https://shop.royalmail.com/barcoded-sheet-of-25-x-1-stamps) Catalogue code DB100 you will need these.

You might like to bind your addressed Affidavit of Status x 3 by using either the following tools: Never use Staples as those damage your paperwork.

For your Master Affidavit of Status: This is my go-to tool for securing my paperwork. SupaClips can be removed for photocopying purposes and reattached using the tool. Good for keeping your master document in order. This is the best tool for your documents, I use it to bind up to 60 pages. No damage and no holes.

The information supplied is a guide; it is written from my experience and that of Carl (Alias Djlockup) who brought to my attention the importance of "correcting your Born Identity." You will be completing an affidavit of truth, and you will need to read it fully and properly before you can start to put the information into practice. I take no responsibility for your mistakes.

You will use the names in which you were given at the time of you being born for this Stage 1 - Affidavit of Status. Name changes by Deed pole/ married names are not relevant at this stage.

2. **Template – the process has been made quite simple: Your Affidavit of Status** Select here for link
This is a sensible illustrated 'How-to' use the template, which will help you to get it right: shows you the correct
Placement of your thumbprints, autograph and the *cancelling out of your £1.00 postage stamp by the post office
(keeping a record of your Post Office Tracking Numbers) and deal with the *pitfalls at the post Office.

2.1 Remember the following:

It is important to use an easy to read font for your Affidavit of Status Size will vary according to font used. It is best of course to use size 11.

All of the fonts below are used daily online, leaflets, instructions and in independent news articles. The following are perfect and clear:

- ✓ Arial
- ✓ Calibri
- ✓ Futura
- ✓ Open Sans
- ✓ Helvetica
- ✓ Verdana
- ✓ Proxima Nova

Note: you should always number your pages (all templates from the Common Law and Equity Channel are numbered); it is recommended that only size 8 is used within the footer space.

Please read and follow the steps within this illustrated guide as below:

- ✓ Prepare and insert the information as requested for your Affidavit of status, address it, autograph it, have it witnessed and then print off 3 of the same.
- ✓ Send 3 Original copies to the following: -
- √ 1 to yourself
- ✓ 1 to the Lord Chief Justice
- √ 1 to the international Criminal Court, Prosecutions office at the Hague
 - Addresses for the above are stated below.





Getting started:

- 2.2 1 X template as on channel Affidavit of Truth
- 2.3 Read the template fully and understand it.
- 2.4 Only amend the font written in **RED**/blue. Do not amend the colours of the context on the front/back page.
- 2.5 The context of the Affidavit of Status should not be changed the spellings and grammar are of its time and it is all correct. Like the Cestui Que Vie Act of 1666, the English language was as written in the same style and manner.
- 2.6 Apart from amending your name, you should not write anything else on the front/back covers.
- 2.7 Do not type using blue or red ink (unless stated); those colours are not suitable for photocopying and over time will fade.
- 2.8 Add a watermark to your Affidavit of Status Link: Go to this article on the channel
- 2.9 Handwriting must not be joined up or cursive. Use quality watermarked 100gram paper and a blue ink biro/ball point or a fine tipped pen to autograph your name.
- 2.10 Where it states to **insert name or insert family name**, please write it in the style of : Compound fact format : should you have a middle name, ensure to insert a hyphen. : Joe-Bloggs : (See below).
- 2.11 When you have completed your Affidavit of Truth, remember to change pages 1-12 to black.
- 2.12 Print off your Affidavit of Status 3 times those are your originals.


Above Compound format of your name should be typed as shown and in the case of autographs, it should be written in your own handwriting using blue ink pen/biro.





- 3. Create 3 original individual printouts of your affidavit.
 - 3.1 It is important to produce <u>3 original printouts of your Affidavit</u>; each one autographed in wet ink. Photocopies are not suitable you must send one original to yourself, the Lord Chief Justice and the International Court at the Hague.

3.2 On page 1 of your Affidavit of truth (**not the cover page**) and at **the top centre**, **add your £1.00 stamp** – **See below**. Do not write on it; the stamp must be left blank initially. The Post Office must have a "Clean Slate" to enable them to cancel out your postage (writing on your stamp will make it invalid).



Note: Read fully before preparing to complete SO THAT YOU FULLY GRASP WHAT IT IS YOU ARE WRITING ABOUT. LEARN IT KNOW IT and Innerstand it.

Delete all text in red/Blue and replace accordingly —
Change all text to black. Do not change any spellings, amend
the context or Styles of text.
This document is set in the style of Calibri
Size 10. insert your
first names Where it states and do the same for your family name (surname).
Do not delete Colons:
Delete all of the above.

On page 2 of your Affidavit of Truth and in the bottom left corner; red thumb-print and write your name in compound fact format (colon dots: space before the first name and hyphenate your middle name, if you have one; then add another colon, then a space before your family name (see detail above), and at an angle (known as drawing of the sword - left to right), date it and red thumb print it (notice how our lady Liberty on the channel profile and our monarch re' postage stamps are facing to the left). This is to reendorse your name(s) shown at Number 12 which you would have written in BLOCK CAPS, Joe blogs, JB, joey etc names you have been known as. This Affidavit is about the name you were given when you were born; do not insert any other names.

3.4 Next go to Page 5 (Part C), and complete "Autograph your name here in blue pen, in Compound Fact Format (like drawing the sword – bottom left to the top right), in your own handwriting, then thumbprint and date in full (do not use forward slashes – if not sure, look at other examples within the Affidavit).

Delete this red text.

- 3.5 Ensure to read everything and every word
- 3.6 On page 6 you will complete Part D Statement of Truth and Statement of Fact, with your 1st names and family name. See example below. Then autograph as shown below.

- 3.7 On Page 7, Part E Witness and Acknowledgement : All witnesses need to print autograph using Compound Fact Format and write using red ink: Each witness should Insert postcode in BLOCK CAPS inside (BN21 8FX) brackets after autograph (delete this red text).
- 3.8 NOTE: Affidavit of truth you witnesses only need to provide their first names.
- 3.9 CESTUI QUE VIE ACT and ROMAN CANON LAW: Do not write or amend anything on the pages: 8, 9, 10, 11 and 12.
- 3.10 On Page 13: Make your final declaration and follow the instructions as per below and insert your £1 postage stamp where shown on the page.

Dated: insert date in words i.e. 28th day of the 6 month in the year of our Lord, two thousand and twenty-two

By: Insert First Names: of the family insert your family name

Place Your £1 postage stamp where it is shown below; then, like drawing the sword autograph your name across the stamp in blue pen (in your own handwriting) and write from the bottom left to the top right in Compound Fact Format. Next, finally endorse your autograph by adding your red thumb print.

Insert your stamp here.

Delete this box

- 3.11 Place your Affidavit of Status to one side whilst you prepare your 3 envelopes
- 3.12 Be organised: Go to the post office and collect a roll of **Special Delivery, Signed for Labels and a couple of international Tracked postal labels** these are free and you only pay when you use the postal/shipping service.
- 4. Prepare and address accordingly 3 x C4 Sized envelopes (no window)
 - 4.1 Place the appropriate tracking labels: *Special Delivery/Signed for, International tracking Label onto each one of your 3 envelopes:
 - 4.2 A brown envelope is preferable (it is earthy) select here to get a reminder of how it looks.
 - 4.3 Address one to yourself (home address) and using a paperclip attach the Affidavit of Truth onto the outside of it/ or ½ way into the envelope do not fold it, do not fully insert into the envelope and do not seal the envelope until your postage stamp on page 1, has been cancelled out by the Post office staff.
 - 4.4 Repeat step 4.3 for the **Hague and the Lord Chief Justice addressing the envelopes to those.
 - 4.5 Next you will peel off the tiny tracker number(s) labels from all 3 mentioned above and stick those onto your own self-addressed Affidavit of Truth document. Please note: Your Special Delivery/Signed for Tiny Tracking number needs to be placed below the £1 postage stamp.



- 4.6 Prior to going to the post office, you must complete your 3 affidavits in full.
- Follow the Illustrated Guide in full.
- Get organised; take your pen and red ink to the post office.
- Referencing page 1: Do not autograph until your 3 Affidavits with £1 stamps have been cancelled out. Once cancelled-out, you must not remove your Affidavits from the post-office.

CANCELLING-OUT YOUR £1
POSTAGE STAMP.

You must not take it out of the Post Office; to do so, will make it void!

4.7 You will take all 3 original Affidavit (not copies – each one must be an original autographed in wet ink) to the Post Office and get the £1 postage stamp (on each) on page 1, cancelled out.

Note: Do not fold your Affidavit of Truth

- 4.8 International Tracking Service is required when sending outside of the UK and for this you will need to complete a form. See below for details;
- -

a. See below for addresses

Time saving Tip! For the (2) International Court of Justice at the Hague – Go to the post Office and ask for an International Tracking Label (you only pay when you ship/post). Once home, you can peel off the tiny tracking number and stick it onto your self-addressed Affidavit of Status.


- b. the (3) Lord Chief Justice, UK, place the Special Delivery/Signed for tiny tracking number directly onto your original Affidavit of Status prior to posting to yourself.
- 4.9 Tracking your mail ensures a guaranteed time of delivery. This postal method should be signed for by the addressed/addressee). International label Netherlands is Orange (CN 22B), UK Special Delivery is Silver and the UK Signed for is Orange.

Send the 3 Original Affidavits to the following addresses at the same time (rule of 3) - in order of importance: -

- 1. Yourself
- The International Court of Justice Prosecutions office.
 The Hague The Netherlands Po Box 19519 2500 CM,
- 3. Lord Chief Justice
 lan Burnett,
 The Right Honourable Lord Burnett of Maldon
 The Royal Courts of Justice Strand London WC2A 2LL
- 4.10 Presentation matters: For the Hague and the Lord Chief justice, you should present those Affidavit bound.

 See page 5 for this information.





The above CN22 form can be downloaded online; it needs to be completed prior to sending your document to the Hague and other locations abroad.

- 4.11 Go to the Post Office and pay for your Special Delivery/or Signed For postage/ OR international Tracked. Ensure to get the receipt and keep for your records. Remember, get to know your Post Office and befriend them.
- 4.12 Note: You can check online to see who signed for your notice by selecting this link: https://www.royalmail.com/track-your-item Be sure to have your receipt. This will provide the tracking number upon it.
- 4.13 Print off a copy of the online Tracking details/ document and photocopy your receipt onto it. If you can, scan your receipt.

5. Universal Postal Union: At the Post Office and how to deal with the Post Office Staff.

5.1 A little bit of history: Due to the Post Offices being *privatised back in 2015, all of UK Post Offices are now franchises and due to this, the Post Office staff do not understand what it means to "cancel the postage out" under Universal Postal Union Rules (this may be down to lack of training).

*Prior to 2015, all PO's would naturally cancel out paid-for documentation, Postage Stamps and Bank Giro Slips etc, to ensure the lawful jurisdiction (documentation docked at the Post Office over Port authorities) and thus prevent the unlawful re-use of the postage; also, providing evidence of which post office provided the service.

In the past you would have presented to the PO, your Bank Giro Slip with your payment for various bills. The Post Office staff would stamp both parts of the Bank Giro Slip: above and below the tear line (this ensures jurisdiction). The customer would be given back the top part with a stamped receipt.

5.2 Under Universal Postal Union, the cancellation of the postage stamp upon the document is paramount. It ensures that the post office under the Universal Postal Union has full control/jurisdiction over your paperwork.



Below is a cancelled-out (obliterated) postage stamp upon the Affidavit of Truth

5.3 Using a stamp for postage without cancelling it is prima facie evidence that the postmaster of the local PO is committing mail fraud by taking a customer's money and not providing the paid-for service and providing you with the power of a cancelled stamp, as required under the provisions of the UPU (Universal Postal Union). There are 192 member countries and here in the UK, the Queen is the Postmaster General for the United Kingdom of Great Britain and Northern Ireland.

6. **Getting your £1 postage stamp Cancelled-out.**

- 1) send to yourself
- 2) Send to Lord Chief Justice
- 3) International Criminal Court, at The Hague.
- 6.1 Go into your local Post Office with your Affidavit of Truth x 3 (get to know them) and ask the Postmaster/Post Lady to cancel-out the postage stamp on page one of each Affidavit: as per the information above. Do not write on the stamp prior to it being cancelled-out. Any marking upon your soon to be cancelled-out postage will make it void (it is classed as "used postage").
- 6.2 Should they refuse, explain how they are committing mail fraud. See above information above regarding Mail fraud by PO.
- 6.3 Once that they have cancelled-out each of the stamps, you can then autograph the cancelled-out stamps in : Compound-Fact : Format, red thumb ink each one and write in the style of drawing the sword.
- 6.4 Pay the fees for the Special Delivery/ Signed for and the international Signed for Tracking service. You will have to complete the international form with regards to sending your Affidavit to the Hague in the Netherlands.
- 6.5 See below, for the UPU/Royal Mail regulator show this to the Post Office.

- 6.6 Ensure to get your tracking receipts.
- 6.7 **Well done!** You passed the first hurdle.. you have started the process of taking back your life: Your Affidavit of Status has also been posted to yourself.
- 6.8 Now, it is all about the waiting... Wait 30 days and then the you will be able to complete Stage 2



7. What Next – You have received back your Affidavit of Status and Truth

Another day has dawned and Royal Mail has delivered your Self-Addressed Affidavit of Status back to you. **Yippee Ki Yay!**

- 7.1 Next **step**: Open your affidavit of truth... Be careful to not damage the envelope (purchase a letter opening knife).
- 7.2 Photocopy your original Affidavit 10 times or more for future use <u>you will send those copies out to those who are mentioned later in this guide.</u> Once that you have photocopied your original, carefully put it back into its envelope and file it away into a safe or a locked drawer.
- 7.3 Never send your original Master Affidavit of Status out to anyone else; this is your evidence and you have copyright over it. You may need it one day in Court and it holds all the evidence,
- 7.4 Note: Keep a record of who you have sent your Affidavit to.
- 7.5 I personally like to record on a spreadsheet; some people write it in a notebook and add the tracker numbers against each of the addressed.
- 8. For the following addresses, send out the photocopies you made of your own affidavit (see above) after you have received it back to yourself. Always practice due diligence and check to see if those who are named are still in office.

IT IS IMPORTANT TO RESEARCH THE CORRECT NAMES FOR THE FOLLOWING OFFICES; DO NOT SEND YOUR DOCUMENTS UNAMED – FAILURE TO ADD THE CORRECT NAMED PERSON (TOP CEO/OR SPEAKER OF THE HOUSE), WILL RESULT IN YOUR MAIL BEING RETURNED TO SENDER.
